# Summerfield North—Honeycutt Creek Greenway

Please see below concerning exciting news about the proposed greenway trail funded by the City of Raleigh through our neighborhood. As some of you may know this capital improvement project has been in the planning stages for several years and it appears the greenway will be a reality for construction possibly in the fall of 2010. While the meeting/workshop is still a couple of months away I nevertheless want to bring to your attention the progress that is being made. As you may already know greenways are usually considered an amenity to a neighborhood if in fact they are designed and constructed with the best interest of the community/neighborhood. It is our cumulative voice that will ensure the design and construction of the greenway is in fact done right.

At this time, the City and their consultant (WSP Sells) have provided 60% of the design of the greenway, which will be shared at an upcoming meeting that will likely be in October. A specific time and place will be set later for this meeting and I will inform everyone in the neighborhood. Nevertheless, I along with others with the SNNA Board will be attending this meeting(s) and I will keep you the neighborhood informed of its progress. I encourage you all to attend any meeting and provide your feedback to the proposed design of the greenway. Likewise, I also encourage those that can't attend the meeting still provide me your written feedback (email is fine) and I will convey over the right people at the City.

In closing if you have any feedback regarding the proposed greenway then please email to me your comments at the following address of [president@summerfieldnorth.com](mailto:president@summerfieldnorth.com). At this time I ask that you do not express your comments directly with the City or their consultant. It is best to consolidate our comments and I will be the liaison of the everyone comments before the meeting this fall. Of course you are encouraged to express your comments in person at the upcoming meeting(s) but at this time lets please ensure that all comments are siphoned through myself back to the City. Thank you for understanding and I look forward to hearing your feedback.

Good afternoon. I am contacting you today on behalf of the City of Raleigh Parks and Recreation Department. My engineering firm, WSP SELLS, is the lead survey and engineering consultant for the ongoing Honeycutt Creek Greenway project. In the next few days many of the Summerfield North residents will be receiving a letter from the City providing an update on the project, a summary of the design, project mapping, and contact information for their use in providing feedback. This project has reached what we consider to be a 60% design; meaning the alignment and many of the design features are set, but there is still work to be done to prepare for construction. The design calls for providing a connection between the City-owned land along East Fork Mine Creek and Strickland Road through Summerfield North via a "Wayfinding" section. The City will propose to enhance and widen existing sidewalk along Clear Brook, Mourning Dove, and Running Cedar. The design calls for extending the sidewalk section to the edge of curb and using an 18" wide section of stamped concrete along the edge of curb to establish a section of the sidewalk where mailboxes and signage can be placed. This will eliminate the vegetated median currently in place between the curb and the sidewalk but will allow for more appropriate use as a greenway connection.

I have attached a copy of the letter and mapping, as well as a map highlighting the property owners who will receive a copy of this letter. We encourage you to share this information with the neighborhood and provide feedback as indicated in the closing of the letter. It is our common goal to provide this greenway section as an amenity to Summerfield North. The City proposes to do work only within the Right of Way.
